Off Licence

Section 17 to 20, 64 and 135, Sale and Supply of Alcohol Act 2012

Pursuant to the Sale and Supply of Alcohol Act 2012 (the Act), **Ocean View Hospitality Limited** (the licensee) is authorised to sell or deliver alcohol on or from the premises situated at **152 Trig Hill Road Waiheke Island Auckland 1081**, and known as **Tuapae**, to any person for consumption off the premises and to supply alcohol free, as a sample, for consumption on the premises.

The authority conferred by this licence must be exercised through a manager or managers appointed by the licensee in accordance with Subpart 7 of Part 2 of the Act.

CONDITIONS

The conditions of the licence are as follows:

- (a) No alcohol is to be sold on or delivered from the premises on Good Friday, Easter Sunday, Christmas Day, or before 1 pm on Anzac Day.
- (b) Only alcohol which is grape wine or fruit or vegetable wine made on the premises or from produce harvested from land on which the premises are situated may be sold on Easter Sunday.
- (c) Only alcohol the following types of alcohol may be sold under this licence:
 - (i) Grape wine or fruit or vegetable wine made on the premises or from produce harvested from land on which the premises are situated.
 - (ii) Alcohol manufactured by or for the licensee company.
- (d) Alcohol may be sold only while the premises are operating as a winery and continue to qualify under section 32(1)(b) of the Act, and only during the following days and hours:

Monday to Sunday

9.00am to 6.00pm

- (e) Drinking water is to be freely available to customers immediately adjacent to any alcohol that is being supplied free as a sample on the premises.
- (f) The social responsibility policy submitted on 22 March 2023 must be complied with.
- (g) No intoxicated persons may be allowed to enter or to remain on the premises.
- (h) Appropriate signage regarding the restrictions on the supply of alcohol to minors and intoxicated persons must be prominently displayed adjacent to every point of sale.
- (i) The whole of the premises is undesignated.

DURATION

Subject to the requirements of the Act relating to the payment of fees, and to the provisions of the Act relating to the suspension and cancellation of licenses, this licence continues in force—

- (a) either-
 - (i) until the close of the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 12 months after the day it was issued; but
- (b) if an application for the renewal of the licence is duly made before the licence would otherwise expire, either—
 - (i) until the close of the period of 3 years after the period for which it was last renewed; or
 - (ii) if it has never been renewed, until the close of the period of 4 years after the day it was issued.

This licence expires at the close of 22nd August 2024 unless renewed.
